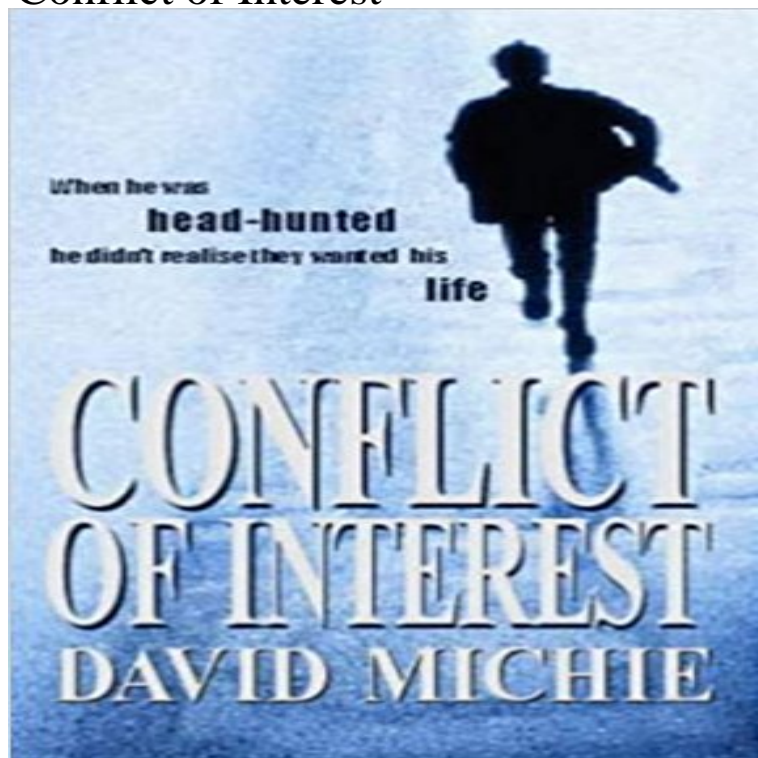


Conflict of Interest
